## Terms & Conditions Of Trade

1. In the event of Wealleans Allied Petroleum Ltd granting credit terms to the customer then the following shall apply:
  - I. Payment of all accounts is due by the due date as stated overleaf: Payment shall be made on the 20th of the month following delivery unless agreed otherwise.
  - II. That should the customer default in the payment of any monies due under the Credit Application then all monies due to Wealleans Allied Petroleum Ltd shall immediately become due and payable & shall be paid by the customer within SEVEN (7) days of the date of demand and Wealleans Allied Petroleum Ltd shall be entitled to charge interest at the rate of 3% per month on all overdue accounts from the due date until the date of actual payment.
  - III. Any expenses costs or disbursements incurred by Wealleans Allied Petroleum Ltd in recovering any outstanding monies including debt collection agency fees & solicitors costs shall be paid by the customer.
  - IV. Wealleans Allied Petroleum Ltd shall be entitled without notice to terminate any credit arrangement with the customer in the event of the customer defaulting in any of the terms & conditions herein contained.
  - V. Wealleans Allied Petroleum Ltd shall be entitled at any stage during the continuance of the Credit Application to request such securities or additional security as Wealleans Allied Petroleum Ltd shall in its discretion think fit and shall be entitled to withhold supply of any goods or credit arrangements until such security or additional security shall be obtained.
2. The Customer hereby acknowledges that the goods & services supplied by Wealleans Allied Petroleum Ltd shall remain the property of Wealleans Allied Petroleum Ltd until payment is received for same. Wealleans Allied Petroleum Ltd hereby agrees to allow the customer to deal, sell or trade with the goods in the normal course of business & for the customer to retain the sales proceeds for such sales or dealings provided that the customer adheres to the Terms & Conditions of the credit application. In the event of the customer defaulting in any terms of the credit application including the payment of any monies due under the Credit Application, then Wealleans Allied Petroleum Ltd shall have the right (without giving notice) to retake the possession of the goods supplied to the customer. The customer hereby authorises & allows Wealleans Allied Petroleum Ltd or its representative, servant, agent or employee to enter the premises upon which the goods are stored for the purpose of retaking possession of the same. Wealleans Allied Petroleum Ltd shall not be liable for any costs, losses, damages, expenses or any other monies or losses suffered by the customer as a result of retaking possession of the goods.
3. In the case of a Trust Company the customer acknowledges that the Trustee shall be liable for the account & that in addition the assets of the trust shall be available to meet payment of the account.
4. Change of ownership – Registered Particulars  

The customer shall no later than 14 days prior to any proposed change of ownership, change in Registered Particulars, alteration, addition to the shareholding or directorship, notify Wealleans Allied Petroleum Ltd of the proposed change. The customer shall be liable for any goods supplied after such change, alteration or addition unless acknowledged by written acceptance of the intending change, alteration or addition.
